Dear Madame Chair and Mr. Executive Director:

This office represents Evviva Cucina, LLC (hereinafter the "Licensee"), a holder of an annual restaurant all alcoholic beverages license ABCC#144200056 (the "License") in the Town of Westford, d/b/a Evviva Cucina, 7 Cornerstone Square, Westford, MA 01886. Please accept this letter as an appeal of the decision of the Westford Licensing Board (hereinafter the "LLA"), dated July 24, 2014, to suspend the License for three days, attached hereto. The written decision was received by the Licensee on July 26, 2014.

The LLA's decision is based on the ABCC's March 12, 2014 compliance check at the Licensee's location, which resulted in a violation of 204 CMR 2.05(2) and Chapter 138, section 34. The violation was heard before the ABCC on June 24, 2014, and the ABCC suspended the License for 3 days, held in abeyance for a period of two years provided the Licensee remains in compliance with its statutory and regulatory obligations. A copy of that decision is also attached.

Among other things, the LLA's subsequent suspension for the same offense violates the due process rights of the Licensee and the regulatory scheme laid out in Chapter 138 and the subsequent regulations and decisions, the evidence presented at the LLA hearing was insufficient to prove the allegations and the punishment is excessive and arbitrary. Due to the ABCC's prior adjudication of the violation, the LLA is

precluded from adjudicating the issue and suspending the Licensee based on the same facts underlying the ABCC decision.

The Board of Selectmen at their meeting on Tuesday. July 22, 2014, reviewed documents pertaining to the liquor law violation that occurred on March 12, 2014 at Evviva Cucina, 7 Cornerstone Square in Westford.

In response, the Board of Selectmen voted unanimously to issue Evviva Cucina a three day license suspension for the sale of alcoholic beverages. This action is in accordance with the Board of Selectmen's Administrative Penalties for Violation of Alcoholic Beverages Sales to Minors Policy (Policy). This policy is attached for your reference. The Board of Selectmen understands that the Alcoholic Beverages Control Commission (ABCC) was responsible for identifying this violation. However, any future violations identified by either the Town of Westford, or the ABCC, will still be considered in accordance with the Policy, specifically the established guidelines regarding the number of offenses and the length of license suspension.

The dates you are prohibited from selling alcohol will be determined by the Board of Selectmen at their September 16, 2014 meeting.

Evviva Cuema LLC (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, June 24, 2014, regarding an alleged violation of 204 CMR 2.05 (2). Permitting an illegality on the licensed premises, to wit: e. 138, §34 Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Bailey's Report.

The following documents are in evidence:

- 1. Tieensee's Stipulation of Facts; and
- 2. Investigator Bailey's Investigative Report dated March 12, 2014.

There is one (1) audio recording of this hearing.

### **FACTS**

- On Wednesday, March 12, 2014 at approximately 6:28 p.m., Investigators Doyle and Bailey conducted an investigation of the business operation of Evviva Cueina LLC.
- 2. An underage operative, working with investigators, was in possession of a can of Budweiser beer. The underage operative was not asked for identification.

### **CONCLUSION**

Based on the evidence, the Commission finds the licensee violated 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Therefore, the Commission suspends the license for three (3) days of which three (3) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
