Town Manager Ross stated she may need to procure consulting services in order to keep the project moving forward. She suggested either DRA capital funds or a FinCom reserve fund transfer as we cannot wait until Annual Town Meeting. The board supported using DRA funds if replenishment was sought at Annual Town Meeting, or a FinCom reserve. The board requested the Task Force not seek funding from other boards/committees without first obtaining BoS approval, and reiterated their previous opinion to postpone placing historic and affordable housing restrictions on the property until a viable redevelopment project is identified
